Thank you for referring Carly for a pre-placement assessment.

#### Health history

I have reviewed the pre-placement questionnaire for the above-named individual and subsequently carried out a telephone assessment today.

Carly had recent surgery in May 2023 and then again in July 2023 to remove a cancerous mole from his right wrist. She reports that this has been successfully removed and there are no further treatment plans for this. She is under six monthly reviews with her consultant at the hospital as part of her post-surgery surveillance plan.

Carly suffers from anxiety and reports this has been well-managed over the past 5 years with medication. In the workplace, she has undertaken roles working with people on a daily basis with no impact on her symptoms. She is naturally feeling slightly anxious about commencing a new role, however, she is familiar with the school as she is currently working there as a cleaner five afternoons per week.

Carly has a history of gynaecological symptoms and she has visited her GP who has prescribed medication to support her with these symptoms. I do not anticipate this to impact her role in the future. I have advised her to speak with her GP again if any of these symptoms are exacerbated and impact her ability to carry out day to day activities.

In my opinion, Mrs Carly Wilson is fit for the role of Science Technician with advice and recommendations.

#### Advice and recommendations

Carly is automatically covered under the disability provision of the Equality Act (2010) due to her recent cancer diagnosis, although she reports this has been successfully removed, she will remain under the surveillance programme which is currently every six months and it would be helpful if she was supported with time away from work to attend medical appointments if these occur within her working hours.

Given her history of anxiety, I do not anticipate this condition to impact her in the workplace. Management may wish to undertake regular 1:1s with Carly initially as additional support whilst they settle into their new job role and working environment.
